- 2. AND WHEREAS on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 20.01.2015 for its willingness of Two basic units in B.Ed. course and adherence of provisions of new Regulations.
- 3. AND WHEREAS, provisional revised recognition order was not issued to the institution on for conducting B.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-2016.
- 4. **AND WHEREAS,** the compliance was not submitted by the institution considered by the ERC in its 267^{th} Meeting held on $10^{th} 11^{th}$ February, 2019 and as decided to issue the show cause notice u/s 17(1) on 21.02.2019 to the institution.
- 5. **AND WHEREAS**, the ERC in its 278th Meeting held on 16th 18th January, 2020, considered the matter along with the reply received on 24.04.2019 submitted by the institution in response to SCN dtd. 21.02.2019 and decided to issue the Final Show Cause Notice u/s 17(1) dtd. 28.01.2020.
- 6. AND WHEREAS, the ERC in its 280th injecting held on 29th February & 1st March, 2020 considered the matter along with the reply received on 10.02.2020 submitted by the institution in response to Final Show Cause Notice and decided as under:-
 - The institution has fulfilled all criteria as per NCTE Regulations, 2014 in compliance to final show cause notice issued on 28.01.2020. Hence, continuation of Revised Recognition Order (RRO) be issued.
- 7. Now Therefore, the ERC decided to permit the institution i.e. ACC Jain College of Education, Vill- Joypur, PO.- Seharakuri, PS- Md. Bazar, Dist.- Birbhum, West Bengal-731127 (Code No. APE00887) for continuation of recognition for B.Ed. course of two-years duration with an intake of 100 students (Two basic units) subject to fulfilment of the following conditions:-

- a) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- b) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- c) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- d) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- e) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
- 9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10.  - e) Free charged from students.
 - f) Available infrastructural facilities.
 - g) Facilities added during the last quarter;
 - h) Numbers of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information, if it so desires.
